- a. Member acknowledges that the Member should use a dedicated Communications Device that is used solely for accessing the Services in order to minimaize potential unauthorized access to Member's Accounts'
- b. The person designated by the Member in any account resolutions or otherwise as the authorized representative of the Member (the "Administrator") will be responsible for the following functions with respect to all Services: (a) establish access rights to all Services by representatives of the Member; receive communications generated by the Communications Services or Service systems; approve, reject or modify Automated Clearing House ("ACH") batch transactions that require approval; add, modify, and delete ACH batch template definitions: submit ACH batches to SCU: define which participants are included in ACH batches; individual user rights, including authorization to Accounts and dollar thresholds; assign user passwords or other Security Devices to representatives of the Member; and in all other matters represent the Member with respect to the Services. The Member may change the Administrator, or appoint additional Administrators, by giving written notice to SCU. SCU will not be under a duty to inquire as to the authority of the Administrator or the propriety of any instructions given to SCU by the Administrator or any person designated by the Administrator or any other person authorized to act on behalf of the Member.
