

CEFCU® "Holiday 2018 Email Contest" Official Rules

Each entry has an equal chance of winning. No purchase necessary to enter or win. A purchase will not improve your chance of winning. Prizes are as follows: one grand prize of a \$500 Mastercard® Gift Card, five second place prizes of a \$100 Mastercard® Gift Card, and ten third place prizes of a \$50 Mastercard® Gift Card. All federal, state, and local laws and regulations apply. Contest open to U.S. residents 18 years of age or older as of November 1, 2018. Employees, officers, and directors of CEFCU, CEFCU representatives or agents and their immediate families and persons with whom they are domiciled, its subsidiaries and affiliates, its advertising agencies, and its attorneys and consultants involved in this Contest are not eligible to win. Void outside the 50 United States, in the District of Columbia, Florida, New York, and Rhode Island, and where prohibited, taxed, or restricted by law. (2) Online Entry. You may also enter the Contest by entering your name, address, email address, and telephone number on the web entry form located at www.cefcu.com/holiday by selecting the "Holiday 2018 Email Contest Entry Form" link. Limit one online entry per valid email address. Limit one Automatic Entry per CEFCU member.
- 3. Eligibility: You do not have to be a CEFCU member to enter. The Contest is open to residents of the United States who are 18 years of age or older as of November 1, 2018. Employees, officers, and directors of CEFCU, CEFCU representatives or agents and the immediate families and person with whom they are domiciled, its subsidiaries and affiliates, its advertising agencies, and its attorneys and consultants involved in this Contest are not eligible to win. Participation in this Contest constitutes agreement by each entrant to these official rules.
