SWEEPSTAKES OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASING PRODUCTS OR SERVICES FROM CALIFORNIA COAST CREDIT UNION WILL NOT IMPROVE YOUR CHANCES OF WINNING. EACH ENTRY HAS AN EQUAL CHANCE OF WINNING. THIS PROMOTION IS IN NO WAY SPONSORED, ENDORSED, OR ADMINISTERED BY OR ASSOCIATED WITH FACEBOOK. The "Gulls Game Ticket Sweepstakes", begins 12:00 PM Pacific Standard Time (PST) on November 6, 2018 and ends 12:00 PM PST on Tuesday, November 13 (Sweepstakes period). By entering the sweepstakes entrants accept and agree to be bound by these Official Rules. Sweepstakes void where prohibited by law. California Coast Credit Union is the sponsor of this Sweepstakes (Sponsor).

WHO MAY ENTER: Entrants must be at least 18 years of age, have valid U.S. government issued identification and valid tax identification number. Credit Union employees, officials, and members of their immediate families are not eligible to participate in the Sweepstakes. Business entities are not eligible to participate. Sweepstakes is void in Puerto Rico, U.S. territories and possessions outside of the United States, and where restricted or prohibited by law.

HOW TO ENTER: To qualify, comment on the official contest post on Facebook. **LIMIT: ONE (1) ENTRY PER PERSON.** All entries must be received by 12:00 PM PST on November 13, 2018.

Prize: Four (4) Center-Ice Tickets to the San Diego Gulls Game on November 16, 2018 at Valley View Casino Center. The Approximate Retail Value (the "ARV") of the prize is \$200. One (1) winner will be chosen in a random drawing on November 13, 2018 and contacted via Facebook in the comments of the original post and with a Facebook message. Odds of winning are based upon the number of entries. Based upon California Coast Credit Union's estimate of 100 entries, the odds of winning the prize are 1 chance in 100. If the prize remains unclaimed after 12:00 PM PST on Wednesday, November 14, 2018 or the winner does not meet eligibility qualifications, a second random drawing will be held. The prize will be delivered via email to the winner. Prize is not transferrable.

Liability/General Rules: California Coast Credit Union is not responsible for any loss which may occur in connection with the "Gulls Game Ticket Sweepstakes." Entrants agree to hold California Coast Credit Union harmless from any liability arising from participation in the Sweepstakes or the acceptance, receipt, possession, or misuse of the prize. California Coast Credit Union and each of its officers, directors, employees, members, representatives and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of entrants and/or winners arising from, or in connection with, acceptance, receipt, possession, or use/misuse of prizes awarded or participation in the "Gulls Game Ticket Sweepstakes." Prizes cannot be substituted, assigned or transferred by winners. California Coast Credit Union reserves the right to disqualify entrants who fail to follow these Official Rules or who make any misrepresentations relative to the Sweepstakes and redemption of prize.

Sweepstakes Conditions: This Sweepstakes is subject to all applicable federal, state and local laws. By participating, entrants agree to be bound by these Official Rules and the decisions of the Sponsor and waive any right to claim ambiguity in the Sweepstakes or these Official Rules. Sponsor is not responsible for lost, late, misdirected, undeliverable, illegible, or incomplete entries, whether due to system errors or failures, faulty transmissions or other telecommunications malfunctions, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer or telephone transmissions, typographical or system errors and failures, technical malfunctions, or otherwise. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair practices or intending to annoy, abuse, threaten, or harass any other entrants or Sponsor. Arbitration: Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes or any prizes awarded, shall be resolved individually, without resort to any form of class action, and exclusively, by final and binding arbitration under the rules of the American Arbitration Association ("AAA") and shall be held at the AAA regional office nearest the participant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement, and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorney's fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.

Taxes: Winners are responsible for all tax consequences (if any) of the prize.

Choice of Law: All issues concerning the construction, validity interpretation, and enforceability of these Official Rules, or the rights and obligations of any entrant and California Coast Credit Union in connection with the "Gulls Game Ticket Sweepstakes," shall be governed by, and construed in accordance with, the substantive laws of the State of California, USA.
