

OFFICIAL CONTEST RULES

HORIZON CREDIT UNION #HZCUPETPAWSSE CONTEST GIVEAWAY

ELIGIBILITY

No purchase necessary. The #HZCUpetpawsse (“Promotion”) begins August 3, 2020 and ends on September 7, 2020 (“Promotion Period”). The promotion is open to citizens and legal residents of the United States. Participants must be 18 years of age or older before August 3, 2020. In order to be eligible to receive the prize, entrants must accurately enter their pet photo which includes the Horizon bandana by tagging Horizon Credit Union in a public post on Facebook or Instagram. Photos must be accompanied by the contest hashtag (#HZCUpetpawsse) to be an official entry. Each participant is allowed a maximum of one entry during the promotional period. Employees of Horizon and its subsidiaries and their immediate families (parents, children, siblings, spouses) and members of their households (whether related or not) are not eligible to participate in this Promotion.

PRIZES

The grand prize winner will be selected to win a \$500 Petco e-gift card and will get to choose a qualifying animal rescue organization to receive a \$1,000 donation from Horizon Credit Union. The runner-up will be selected to win a \$250 Petco e-gift card and will get to choose a qualifying animal rescue organization to receive a \$500 donation from Horizon Credit Union. The winner and runner-up will be announced on Horizon’s social media channels and will be contacted through the social media channel on which they entered.

ODDS OF WINNING

Odds of winning depend upon the number of valid entries received. For example, if 1,000 entries are received, the odds of winning would be 2 in 1,000. Up to ten finalists will be selected and opened up to a public vote on social media from September 10, 2020 – September 24, 2020 at 5:00pm. The entry that receives the most combined total “likes” on Facebook and Instagram will win.

PRIZE CONDITIONS

Prizes will be awarded to winners as an e-gift card. Winner will be announced on or around September 25, 2020. If an entrant is found to be ineligible, for any reason and at any time, then the entrant will be disqualified from receiving a prize. Total Approximate Retail Value (“ARV”) of grand prize = \$500.
