

## **CU Difference Art Contest**

To celebrate International Credit Union Day 2021, we want to know what the credit union difference means to you. Create an original work of art to bring to life this year's theme, "Building financial health for a brighter tomorrow." You decide how to express yourself – photograph, video, poem, story, essay, drawing, painting, song, or whatever you can dream up. Submit your entries to OUCU by October 15. A panel of OUCU employee judges will select one winner.

One winning entry will be selected by October 21 to be displayed on our website, social media pages, and in-branch (if applicable). Winners will receive a \$100 deposit into the account of their choice.

Entries will be selected based on quality, creativity, meeting the theme, and overall impression.

### **Contest Theme: Building financial health for a brighter tomorrow.**

We see how you interpret this theme and what it means to you! **The deadline for submitting your work of art is October 15.**

### **Entry Guidelines and Restrictions:**

Entries containing inappropriate imagery including, dangerous, violent, inappropriate or potentially harmful acts, nudity, or obscenity, will be deemed ineligible and may be reported to local authorities.

Any entry will be deemed ineligible if it fails to meet the required specifications, is received before the submission period begins or after it ends, or for any other reason at the sole discretion of Ohio University Credit Union. If your entry is rejected, it will be removed from the contest, and you will be notified via Facebook.

### **How to Enter**

To enter, send an electronic copy of your submission via Facebook Messenger or Instagram Direct Message to @OUCreditUnion.

### **Rules and Conditions**

1. You must have a legal guardian's permission before entering.
2. There is no cost to enter.
3. Entrant must be an OUCU member between the ages of 13-17 to participate in the contest.
4. Entrants are limited to no more than 1 entry.
5. By entering, each entrant agrees to release OUCU, its officers, directors, employees, agents, members, affiliates, suppliers, and distributors from all liability, claims, or actions of any kind whatsoever for injuries, damages, or losses to persons and property which may be sustained in connection with the receipt, ownership, or in connection

with the contest, including without limitation any third party claim for copyright infringement or a violation of an individual's right to privacy or publicity right.

6. Artwork that has been previously published, accepted for publication, or is under consideration by other publications are not eligible.
7. OUCU reserves rights to use all entries on our website and social media pages, as well as rights to reprint and use the winning entry on our website, social media pages, or advertising for editorial and promotional purposes. An attribution line will be included for all works of art. OUCU reserves the right to make minor color or contrast adjustments to the winning entry for purposes of consistency and optimum visibility.
8. Entrants agree that OUCU has the right to publish winning entries without compensation other than the \$100 deposit into the OUCU account of the winner's choice.
9. Void where prohibited by law.
10. Winners will be announced on Oct 21. Images will be judged on originality, composition, and artistic merit. OUCU shall determine contest winners at its sole and absolute discretion. All decisions made by OUCU are final.
11. The winner's list will be displayed at [www.oucu.org](http://www.oucu.org) and on social media.
12. Employees and their immediate family members are eligible to participate.
13. Contest officials reserve the right, at their discretion, to reject any entry that does not conform to regulations, is deemed to be objectionable, or which is of an inappropriate subject matter.
