

**Clark County Credit Union Sunset Open House Giveaway  
OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN.**

**A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. WINNERS WILL BE CHOSEN AT RANDOM.**

By entering the Clark County Credit Union Sunset Open House Giveaway (the "Sweepstakes"), you agree to comply with and be bound by the following Official Sweepstakes Rules (the "Official Rules"). If you do not agree with the Official Rules in their entirety, you are not permitted to enter the Sweepstakes.

**ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO PERMANENT LEGAL RESIDENTS OF THE 50 UNITED STATES or THE DISTRICT OF COLUMBIA, WHO ARE 18 OR OLDER at the time of entry AND members in good standing at Clark County Credit Union.** Employees of Clark County Credit Union (CCCU), ("Sponsor and Administrator") and their parent companies, subsidiaries, affiliates, advertising and promotion agencies and their immediate family members (defined as spouse, siblings, parents and children) and/or those living in the same household (whether related or not) of each are not eligible to enter. Sweepstakes is subject to all applicable federal, state, local and provincial laws and regulations, and is void where prohibited by law. The information provided will only be used for the purposes of this Sweepstakes and as otherwise permitted by Sponsor's privacy policy.

**SWEEPSTAKES TIMING:** The Sweepstakes begins 9:00 am PT on 08/19/2025 and ends 6:00 pm PT on 08/22/2025 (the "Entry Period"). Entries must be received during an Entry Period to be eligible for that Entry Period's drawing and prize. Non-winning entries for an Entry Period will **not** roll over to any subsequent Entry Period. Sponsor's database clock will be the official timekeeper for the Sweepstakes.

**HOW TO ENTER:** There is one (1) method of entry.

To enter, attend the Sunset branch Open House Event 08/19/25 through 08/22/2025 and submit your information using the online form, found here: <https://info.ccculv.org/sunset-grand-reopening>. The form can be accessed by scanning the QR code which will be provided at the event site (the "Entry"). Entries must be received between 9:00 am PT on 08/19/2025 and 6:00 pm PT on 08/22/2025 (the "Entry Period") to be eligible.

**Eligible entries are defined as form submissions received on or before 08/22/2025. Drawing period beings 9:00 am PT on 08/25/2025 (the "Drawing Period"). Membership with Clark County Credit Union is not required.**

**PRIZES & APPROXIMATE RETAIL VALUE ("ARV")/ODDS:** There is one (1) Prize available to be won; a set of two tickets to attend the iHeart Radio Festival on September 19, 2025. **The total ARV of the prize available to be won is: \$825.** There is a limit of one (1) prize per person, per account. Odds of winning a Prize depend on the number of eligible entries received during the Entry Period.

**WINNER SELECTION/NOTIFICATION:** The Sweepstakes is under the administration of the Administrator; whose decisions are final. Potential winner will be selected in a random drawing from among all eligible entries received within the Entry Period on August 25, 2025. Potential winner will be notified by email or phone on or about the corresponding Drawing date and will be requested to verify his/her eligibility by signing and returning, within seven (7) days of this formal notification by Administrator, an Affidavit of Eligibility and a Liability Waiver, a W-9 Form and, where allowable, a Publicity Release (collectively, "the Releases"). Noncompliance will result in disqualification and an alternate winner being selected. Winner is responsible for all applicable federal, state, or local income taxes associated with winning the prize. Winner may be required to furnish his/her social security number for the sole purpose of preparation of any tax forms as required by law.

***SECOND CHANCE DRAWING:***

The potential Second Chance Winner, if any, will be notified by email or phone and will be requested to verify his/her eligibility by signing and returning the Releases, within seven (7) days of this formal notification by Administrator. Noncompliance will result in disqualification and an alternate winner may be selected. Winners are responsible for all applicable federal, state, and local income taxes associated with winning the prize.

**PRIZE CONDITIONS:** If a winner is otherwise eligible under these Official Rules but is nevertheless deemed a minor in his or her state of primary residence, the prize will be awarded in the name of winner's parent or legal guardian who will be required to execute and return the Releases on minor's behalf.
