Official Promotion Details and Rules

HOW TO ENTER

No purchase necessary to enter or win. Purchases made with an Advantage One Credit Union (AOCU) Visa® credit card in Taylor, Michigan qualify for automatic entries. Members may also enter without purchase by submitting a manual entry form as described below.

Automatic Entry: Eligible members who make a purchase in the City of Taylor, Michigan with their **Advantage One Credit Union Visa® credit card** will automatically be entered into the Taylor Grand Opening Credit Card Contest (“Contest”). Entries are based on qualifying credit card transactions made within Taylor, Michigan during the Promotion Period. (ATM withdrawals, cash transactions, and any card-related fees or charges are excluded.)

Manual Entry: Members may also enter manually by submitting **one (1) entry form per week** during the Promotion Period. Completed entry forms may be:

If a manual entry is selected as a winner, the member will receive a \$25.00 deposit into their account.

Promotion Period: Begins September 30, 2025 at 1:00 p.m. ET and ends October 31, 2025 at 11:59 p.m. ET.

ELIGIBILITY

- Open to members of Advantage One Credit Union who are at least 18 years of age.
- Members must be in good standing (i.e., no negative balances, no delinquencies).
- Employees, board members, and their immediate family members are not eligible.
- Void where prohibited.

SELECTION AND PRIZES

- **Total Winners:** 25
- **Prize:** Up to **\$150 credit** on the winner's next credit card statement.
 - The credit will match up to \$150 of qualifying purchases made on the day the winner is selected.
 - If the winner entered manually, they will instead receive a **\$25 account deposit**.
- **Total Prize Pool:** Up to **\$3,000**.
- **Limit:** One (1) prize per person during the Promotion Period.
- Winners will be chosen in a **random drawing** conducted by AOCU.
- Odds of winning depend on the total number of eligible entries received.

GENERAL
