

Clark County Credit Union Card Rewards Entertainment Promotion
OFFICIAL RULES

By entering the Clark County Credit Union Card Rewards Entertainment Promotion (the "Promotion"), you agree to comply with and be bound by the following Official Promotion Rules (the "Official Rules"). If you do not agree with the Official Rules in their entirety, you are not permitted to enter the Promotion.

ELIGIBILITY: THE PROMOTION IS OPEN ONLY TO PERMANENT LEGAL RESIDENTS OF THE 50 UNITED STATES or THE DISTRICT OF COLUMBIA, WHO ARE 18 OR OLDER at the time of entry AND members in good standing at Clark County Credit Union. Employees of Clark County Credit Union (CCCU), ("Sponsor and Administrator") and their parent companies, subsidiaries, affiliates, advertising and promotion agencies and their immediate family members (defined as spouse, siblings, parents and children) and/or those living in the same household (whether related or not) of each are eligible to enter. Promotion is subject to all applicable federal, state, local and provincial laws and regulations, and is void where prohibited by law. The information provided will only be used for the purposes of this Promotion and as otherwise permitted by Sponsor's privacy policy.

PROMOTION TIMING: The Promotion begins 12:00 am PT on 06/01/24 and ends at 11:59 pm PT on 06/30/2024 (the "Entry Period"). Entries must be received during the Entry Period to be eligible for 1,500 bonus points. Sponsor's database clock will be the official timekeeper for the Promotion.

HOW TO ENTER: There is one (1) method of entry.

To enter, make a purchase of \$500.00 or more with your Clark County Credit Union Visa DEBIT or CREDIT Card (Infinity Rewards and Platinum Rewards) towards an "entertainment" purchase as defined by MCC industry codes set by the credit union (the "Entry"). Entries must be received between 12:00am PT on 06/01/2024 and before 11:59 pm PT on 06/30/2024 (the "Entry Period") to be eligible. **The spending threshold must be met on a per card basis during the promotional period. This promotion is card-level and is not aggregated at the account level.**

Eligible entries are defined as purchases with CCCU Cards (Debit or Credit) authorized to card within the entry period AND settled by VisaNet on or before 06/30/2024 classified as entertainment purchases, as determined by MCC industry codes set by the credit union. Cash advances and balance transfer transactions are not eligible. Entrant must be a member in good standing to receive bonus points (member is good standing is defined as current on all account and loan obligations with Clark County Credit Union). Each purchase that posts to the billing statement within the required billing posting period, will be considered one (1) entry.

BONUS POINTS AND REDEMPTION: 1,500 Bonus points earned as part of this promotion will be credited to the cardholder's rewards account in the month of July, 2024. Bonus points can be redeemed through the online banking card rewards website, rewards.ccculv.com. The redemption of bonus points is subject to the terms and conditions outlined in the CCCU rewards brochure. For more information, please refer to the brochure. CCCU reserves the right to modify, amend or discontinue the promotion at any time without prior notice.

PROMOTION CONDITIONS: The Bonus Points will be awarded during the month of July 2024 after being verified. Except where prohibited by law, entry and acceptance of prize constitute permission to use winner's name, prize won, hometown, likeness, video tape, photographs, and statements for purposes of advertising, promotion and publicity (including online posting) in any and all media now or hereafter known throughout the world in perpetuity, without additional compensation, notification or permission.

By participating in the Promotion, you (i) agree to be bound by these Official Rules, including all eligibility requirements, and (ii) agree to be bound by the decisions of the Sponsor, which are final and binding in all matters relating to the Promotion.
