CONTEST OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. PURCHASING PRODUCTS OR SERVICES FROM CALIFORNIA COAST CREDIT UNION WILL NOT IMPROVE YOUR CHANCES OF WINNING. EACH ENTRY HAS AN EQUAL CHANCE OF WINNING. The "Baseball Basket Giveaway" (Contest) begins 9:00 AM Pacific Standard Time (PST) on July 28, 2024 and ends 5:00 PM PST on September 2, 2024 (Contest Period). By entering this Contest, entrants accept and agree to be bound by these Official Rules. Contest void where prohibited by law. California Coast Credit Union (California Coast) is the sponsor of this Contest (Sponsor). This promotion is in no way sponsored, endorsed, or administered by or associated with Facebook, Twitter or Instagram.

WHO MAY ENTER: Entrants must be at least 18 years of age, have valid government issued identification and valid tax identification number. California Coast employees, officials, and members of their immediate families are not eligible to participate in the Contest. Business entities are not eligible to participate. Contest is void in Puerto Rico, U.S. territories and possessions outside of the United States, and where restricted or prohibited by law.

HOW TO ENTER: Eligible entrants must complete the form found at <http://www.calcoastcu.org/95>. Eligible entrants may enter this Contest via Online, Facebook, Twitter, Instagram or Mail. The entry methods are described below. **LIMIT: UP TO ONE (1) ENTRY PER PERSON PER CONTEST PERIOD REGARDLESS OF METHOD OF ENTRY.** All entries must be received by 5:00 PM PST, September 2, 2024. Multiple entries received from any person beyond this limit will void all such additional entries. **Online Entry Method:** Entrants must complete the form found at <http://www.calcoastcu.org/95>. **Social Media Entry Method:** Entrant must be a registered user of Facebook (<http://www.facebook.com>), Twitter (<http://www.twitter.com>) or Instagram (<http://www.instagram.com>) to participate in the Contest. If entrant is not a registered user of Facebook, Twitter or Instagram, simply visit the links above to register for free. California Coast will not verify receipt of entries for entrants. All entries submitted become the sole property of California Coast and will not be returned. Prize/Approximate Retail Value: One (1) winner will be chosen the week of September 2, 2024 and will receive one (1) **Baseball Themed Basket**. The Approximate Retail Value (the "ARV") of the prize is \$150. The winner will be contacted via email, phone or direct message. Odds of winning are based upon the number of entries. Based upon California Coast's estimate of 250 entries, the odds of winning any prize are 1 chance in 250. If Sponsor is unable to contact the prospective Winner within 24 hours of being contacted, or if the prospective Winner does not meet eligibility qualifications, his/her prize will be forfeited and an alternate prospective Winner shall be selected. The prize will be sent via email. Prize is not transferrable.

Selection of Winner:

A winner will be selected at random on September 4, 2024. One (1) winner will be selected at random.
