

Clark County Credit Union Law Enforcement Week Prize Drawing

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. WINNERS WILL BE CHOSEN AT RANDOM.

By entering the Clark County Credit Union \$1,000 VISA Gift Card Giveaway (the "Sweepstakes"), you agree to comply with and be bound by the following Official Sweepstakes Rules (the "Official Rules"). If you do not agree with the Official Rules in their entirety, you are not permitted to enter the Sweepstakes.

ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO PERMANENT LEGAL RESIDENTS OF THE 50 UNITED STATES or THE DISTRICT OF COLUMBIA, WHO ARE 18 OR OLDER at the time of entry AND members in good standing at Clark County Credit Union. Employees of Clark County Credit Union (CCCU), ("Sponsor and Administrator") and their parent companies, subsidiaries, affiliates, advertising and promotion agencies and their immediate family members (defined as spouse, siblings, parents and children) and/or those living in the same household (whether related or not) of each are eligible to enter. Sweepstakes is subject to all applicable federal, state, local and provincial laws and regulations, and is void where prohibited by law. The information provided will only be used for the purposes of this Sweepstakes and as otherwise permitted by Sponsor's privacy policy.

SWEEPSTAKES TIMING: The Sweepstakes begins 12:00am PT on 1/9/23 and ends at 11:59 pm PT on 1/13/23 (the "Entry Period"). Entries must be received during an Entry Period to be eligible for that Entry Period's drawing and prize. Non-winning entries for an Entry Period will **not** roll over to any subsequent Entry Period. Sponsor's database clock will be the official timekeeper for the Sweepstakes.

To enter, Law Enforcement members should submit their name and email on our form located at <https://info.ccculv.org/law-enforcement-week> (the "Entry"). The second method is to post on official CCCU social media channels for an additional entry. Entries must be received between 12:00am PT on 1/9/23 and 11:59 pm PT on 1/13/23 (the "Entry Period") to be eligible.

Eligible entries are defined as members of local law enforcement who enter the drawing. Drawing period beings 12:00am PT on 1/14/23 and 11:59 pm PT on 1/17/23 (the "Drawing Period"). Selected entry does not need to be a member of Clark County Credit Union, but if they are a member they must be a member in good standing to accept prize (member is good standing is defined as current on all account and loan obligations with Clark County Credit Union).

PRIZES & APPROXIMATE RETAIL VALUE ("ARV")/ODDS: There are six (6) Prizes available to be won; one (1) opportunity to receive \$1000.00 VISA gift card. There are five (5) opportunities to win a \$50 restaurant gift card. **The total ARV of all prizes available to be won is: \$1,300.00.** There is a limit of one (1) prize per person. Odds of winning a Prize depend on the number of eligible entries received per Entry Period. Need not be a member to win.

WINNER SELECTION/NOTIFICATION: The Sweepstakes is under the administration of the Administrator; whose decisions are final. Potential winners will be selected in a series of random drawings from among all eligible entries received within each Entry Period on or about the corresponding Drawing date indicated in the Entry Period & Drawing Schedule above. Potential winners will be notified by phone and phone on or about the corresponding Drawing date and will be requested to verify his/her eligibility by signing and returning, within seven (7) days of this formal notification by Administrator, an Affidavit of Eligibility and a Liability Waiver, a W-9 Form and, where allowable, a Publicity Release (collectively, "the Releases"). Noncompliance will result in disqualification and an alternate winner being selected. Winners are responsible for all applicable federal, state, or local income taxes associated with winning the prize. Winners may be required to furnish his/her social security number for the sole purpose of preparation of any tax forms as required by law.

SECOND CHANCE DRAWING: There will be no Second Chance Drawing.

The potential Second Chance Winners, if any, will be notified by email and phone and will be requested to verify his/her eligibility by signing and returning the Releases, within seven (7) days of this formal notification by Administrator. Noncompliance will result in disqualification and an alternate winner may be selected. Winners are responsible for all applicable federal, state, and local income taxes associated with winning the prize.

PRIZE CONDITIONS: If a winner is otherwise eligible under these Official Rules, but is nevertheless deemed a minor in his or her state of primary residence, the prize will be awarded in the name of winner's parent or legal guardian who will be required to execute and return the Releases on minor's behalf. If the Releases are returned as undeliverable or if the selected winner cannot accept or receive the prize for any reason, or he/she is not in compliance with these Official Rules, the prize will be forfeited.

Prizes are not redeemable for cash. Prizes are non-assignable or transferable. No substitution is permitted except if prize is unavailable, in which case a prize of equal or greater value will be awarded. Any other incidental expenses on prize not specified herein are the winner's sole responsibility. The prizes will be awarded within 8-10 weeks of each winner being verified. Winners assume all liability for any injury or damage caused or claimed to be caused, by participation in this Sweepstakes or receipt or use of the prize. The Released Parties have not made nor are in any manner responsible or liable for any warranty, representation or guarantee express or implied, in fact or in law, with respect to the prize, including, without limitation, to the prize's quality or fitness for a particular purpose. The Released Parties are not responsible for any typographical or other error in the advertising for the Sweepstakes, administration of the Sweepstakes or in the announcement of the prize. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the CCCU primary member on the member share account linked to the loan number, at time of entry. The Released Parties are not responsible for: (i) error, omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, telephone line, electronic, computer, hardware or software malfunctions of any kind, or inaccurate transmission of or failure to receive entry or email information by Sponsor on account of technical problems or traffic congestion on the Internet or at any web site or any combination thereof or any other reason beyond Sponsor's control; or (ii) any injury or damage to persons or property, including but not limited to death, which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use of the prize.

By participating in the Sweepstakes, you (i) agree to be bound by these Official Rules, including all eligibility requirements, and (ii) agree to be bound by the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. Inclusion in such random drawing shall be each entrant's sole and exclusive remedy under such circumstances.

participating, entrants agree that any and all disputes arising out of or relating in any way to this Sweepstakes shall be resolved individually, and without resort to class action, exclusively by a state or federal court located in Nevada. Entrants hereby irrevocably consent to the personal jurisdiction of said courts and waive any claim of forum non conveniens or lack of personal jurisdiction that they may have. Should there be a conflict between the laws of the State of Nevada and any other laws, the conflict will be resolved in favor of the laws of the State of Nevada. All judgments or awards shall be limited to actual out-of-pocket damages (excluding attorneys' fees) associated with participation in this Sweepstakes and shall not include any indirect, punitive, incidental and/or consequential damages.
