



# Official Rules

'Tis the Ski-son Social Media Event

## Eligibility

No purchase necessary. The 'Tis the Ski-son ("Promotion") begins 12/02/24 and ends on 12/27/24 ("Promotion Period"). The promotion is open to citizens and legal residents of the United States. Participants must be 18 years of age or older before 12/02/24. In order to be eligible to receive the prize, entrants must follow Horizon Credit Union's social media profile, like the specific post about which mountain they would like to win tickets to and write a comment tagging one friend they would take. Limit one comment per user. One bonus entry if they share the post on their personal page. Employees of Horizon and their immediate families (parents, children, siblings, spouses) and members of their households (whether related or not) are not eligible to participate in this promotion.

## Contest Details

'Tis the Ski-son is a social media giveaway. Each week on Horizon Credit Union's social media channels (Facebook & Instagram), we will post a new ski mountain/resort to be eligible to win tickets. The user must follow Horizon Credit Union's social media profile, like that specific post, comment, and tag one friend they would take with them if they were to win. Limit to one entry per person. One bonus entry if they share on their profile

## Prizes

The prize is two lift tickets to the specific mountain they enter. Estimated Value = Range of \$200-\$380

## Odds of Winning

Odds of winning depend upon the number of valid entries received. For example, if 1,000 entries are received, the odds of winning would be 1 in 1,000.

## Prize Conditions

If an entrant is found to be ineligible, for any reason and at any time, then the entrant will be disqualified from receiving a prize. Total Approximate Retail Value ("ARV") of prizes = \$380. All federal, state, local or other tax liabilities (including income taxes) arising from this Promotion will be the sole responsibility of the winner. Except where prohibited by law, the winner's acceptance of the prize constitutes permission for Horizon to use winner's name, photograph, likeness, statements, biographical information and voice, in all forms of media, in perpetuity, without further compensation.
