Blessings in Disguise Ticket Giveaway

Eligibility

No purchase necessary. The Blessings in Disguise Ticket Giveaway ("Promotion") begins 07/06/26 and ends on 07/08/26 ("Promotion Period"). The promotion is open to citizens and legal residents of the United States.

Participants must be 18 years of age or older before 07/06/26. Winners will be selected in a random drawing from all eligible entries received during the promotion period. Drawing will occur on or about 07/09/26. Employees of Horizon and their immediate families (parents, children, siblings, spouses) and members of their households (whether related or not) are not eligible to participate in this promotion.

Contest details

Blessings in Disguise Ticket Giveaway is a social media contest where two people have the chance to win two tickets each to the Blessings in Disguise Music Festival at The Podium in Spokane, WA, for Saturday, July 11, 2026.

In order to be eligible to receive the prize, entrants must follow Horizon Credit Union on Facebook or Instagram, like Horizon's Blessings in Disguise post, tag one friend they would like to take in the comments section, and share the post on Facebook or reshare the post on Instagram.

Winners will be announced Thursday, July 9, 2026. Horizon Credit Union will reach out via direct message to confirm the winner's email. We will then send tickets via email. If we do not receive a message of email confirmation within 24 winners will forfeit their prize.

Prizes

The prizes are two sets of two tickets. Approximate value of \$248 per set; total approximate value of all prizes: \$496

Odds of winning

Odds of winning depend upon the number of valid entries received. For example, if 1,000 entries are received, the odds of winning would be 2 in 1,000.

Prize conditions

If an entrant is found to be ineligible for any reason and at any time, then the entrant will be disqualified from receiving a prize. Total Approximate Retail Value ("ARV") of prizes = \$248.
