

Official Rules

Back to School Bucks Online Event

Eligibility

No purchase necessary. The Back to School Bucks ("Promotion") begins 08/06/24 and ends on 09/09/24 ("Promotion Period"). The promotion is open to citizens and legal residents of the United States. Participants must be 18 years of age or older before 08/06/24. For qualifying teachers to be eligible to receive the prize, social media members and viewers must comment and tag the teacher they wish to nominate in the comment section of the original post. Then, the nominated teacher must respond to their tagged comment on how the prize will benefit them this school year. Members and viewers can only nominate one teacher. A teacher can be nominated multiple times. Employees of Horizon and their immediate families (parents, children, siblings, spouses) and members of their households (whether related or not) are not eligible to participate in this promotion.

Contest Details

Back to School Bucks is a social media contest where viewers can nominate their favorite teacher within our Horizon Credit Union footprint: Idaho, Montana, Oregon, and Washington. The teacher must be tagged and commented back, saying how they will use their prize winnings for the school year in order to be eligible to win. We will award 4 teachers, one from each region (Montana, Southern Idaho/Oregon, Spokane/Northern Idaho, and Central Washington) \$300.

Prizes

The prize is four \$300 checks to 4 different teachers. Totaling \$1,200

Odds of Winning

Odds of winning depend upon the number of valid entries received. For example, if 1,000 entries are received, the odds of winning would be 4 in 1,000.

Prize Conditions

If an entrant is found to be ineligible, for any reason and at any time, then the entrant will be disqualified from receiving a prize. Total Approximate Retail Value ("ARV") of prizes = \$300. All federal, state, local or other tax liabilities (including income taxes) arising from this Promotion will be the sole responsibility of the winner. Except where prohibited by law, the winner's acceptance of the prize constitutes permission for Horizon to use winner's name, photograph, likeness, statements, biographical information and voice, in all forms of media, in perpetuity, without further compensation.
