

Eligibility

No purchase necessary. Pet Pawsee ("Promotion") begins on 06/02/2025 and ends on 07/15/2025 ("Promotion Period"). The promotion is open to citizens and legal residents of the United States. Participants must be 18 years of age or older before 06/02/2025. For qualifying participants to receive a prize, they must obtain this year's promotional item, western hat, and place the western hat on or around their pet, capture a picture, and then post that picture on either Facebook or Instagram; make sure their profile is public (so we can see the entries), tag either @HZCUCooperative (Facebook) or @hzcu (Instagram), and they must use #HZCUPetPawsee2025. Participants must also follow Horizon Credit Union to qualify. Employees of Horizon and their immediate families (parents, children, siblings, spouses) and members of their households (whether related or not) are not eligible to participate in this promotion.

Contest Details

Pet Pawsee is a social media contest in which viewers can get a free item (a western hat), place it on or around their pet, take a photo, and enter their pet for a chance to win a \$1,000 donation to a shelter of their choosing, and a one-year subscription to BarkBox. To qualify, viewers must follow Horizon Credit Union on either Instagram or Facebook, tag Horizon Credit Union in the post with their pet, and use #HZCUPetPawsee2024.

Prizes

The first-place prize is a \$1,000 donation to an animal shelter of the winner's choosing, and a one-year BarkBox subscription (\$276 in value). Second place receives a \$500 donation to their chosen shelter and a \$150 Chewy gift card.

Odds of Winning

Odds of winning depend upon the number of valid entries received. For example, if 1,000 entries are received, the odds of winning would be 2 in 1,000.

Prize Conditions

If an entrant is found to be ineligible, for any reason and at any time, then the entrant will be disqualified from receiving a prize. Total Approximate Retail Value ("ARV") of prizes = First place \$276 & Second place \$150. Animal Shelters must be a 501(c)(3) in order to qualify for donation. All federal, state, local or other tax liabilities (including income taxes) arising from this Promotion will be the sole responsibility of the winner.
